Bloomfield was part of Newark in 1666 when that town was settled. It was two hundred years ago in 1812 that

Bloomfield, New Jersey was incorporated as a municipality. In 1796, the congregation of the Old First Church (now the Presbyterian Church on the Green) was formed. It honored Revolutionary War General Joseph Bloomfield by naming the newly formed parish after him, The Presbyterian Society of Bloomfield. In 1812, the town separated from Newark and incorporated as the Township of Bloomfield, taking its name from the aforementioned Presbyterian parish. Bloomfield originally covered 20.52 square miles (now 5.4 square miles) and included Belleville, Montclair, Woodside, Nutley and Glen Ridge, each separating from Bloomfield in 1839, 1868, 1871, 1874 and 1895 respectively.

Dozens of bicentennial events are planned in Bloomfield throughout the year, including a Bloomfield family roots contest, historical presentations and tours, planting of the bicentennial tree, musical performances, an expanded Memorial Day parade, opening of the sesquicentennial (150) time capsule, old fashion bicentennial picnic, Fourth of July fireworks spectacular and the burying of the bicentennial time capsule.
